GATEWAY RETREAT CENTER CONTRACT & BINDING GUIDELINES: GENERAL GUIDELINES:

- A. Please observe all cabin & game room guidelines which are provided for you.*
- B. Lessee must provide bedding and towels for youth cabin rentals.
- C. GRC does not provide programming or kitchen staff. Groups will provide their own meals, speakers, counselors, ushers, first aid attendants, life guards, and all other personnel.
- D. All trash must be picked up and placed in garbage bin located west of Young Lodge.*
- E. Please do not move furniture or equipment (inside or outside) without permission from the director. If furniture or equipment are moved, please return them to the exact place of origin.*
- F. The use of alcohol and unprescribed drugs is strictly prohibited, as is smoking. Violation will be cause for immediate dismissal without refund of contractual obligation.
- G. Use of the waterfront and related equipment must be approved by the director at the time of contract signature. All children must be supervised at all times. Swimming is NOT permitted in Governor Bond Lake. All guests are required to wear modest attire.
- H. Guests must provide at least one supervisor at all times for every ten school aged participants.*
- I. Possession and/or use of any weapons, firearms, fireworks is strictly prohibited.
- J. Guests are to stay in areas designated by this contract only.*
- K. Please - NO PETS!*

*Failure to observe these guidelines will result in an additional cleaning & maintenance fee.

RELEASE OF LIABILITY:

The below-signed Lessee, in consideration of the rental of the recreational facilities and equipment of the Gateway Retreat Center, Lessor, releases the Lessor of liability from or arising out of the use of the leased premises, including, but not limited to, outdoor water sports, canoeing, basketball, volleyball, baseball/softball, teams course, zip line, showers and bath facilities, and all other necessary or related activities and equipment in connection therewith.

Lessee, and members of Lessee's group, shall be permitted to use all such recreational facilities and equipment at each person's own risk, with the knowledge, understanding and agreement that the Lessor shall be exempt from liability for injuries to any person or property on or about such recreational facilities or equipment on or about the leased premises. The Lessee, or members of the Lessee's group, further hereby agree not to file litigation against the Lessor at any time for or on account of any claim for personal injuries, death or property loss, arising or resulting from use of any such recreational facility or equipment on or about the leased premises.

The Lessee agrees to be responsible for any and all damages caused by any member of the group under the supervision of such Lessee.

The Lessor shall not be required to provide a lifeguard at the Lake nor shall Lessor be required to provide supervision for recreational activities, facilities, or equipment engaged in or used by the Lessee, or members of the Lessee's group, and the Lessee hereby agrees to provide its own supervision for the group under the control of the Lessee.

The Lessee shall provide the Lessor with a currently dated liability endorsement for the Lessee's insurer, holding Gateway Retreat Center, Lessor, free and harmless on any and all liability during or subsequent to the use of the Lessor's facility.
